This is to inform you that Securities and Exchange Board of India (SEBI) had filed an interim application bearing I.A. No. 128401/2018, in Civil Appeal No. 13301/2015 titled Subrata Bhattacharya Vs. SEBI & Ors., before the Hon'ble Supreme Court of India, wherein it sought an additional claim a sum of Rs. 85 Crores (plus accrued interest), being the balance auction proceeds of the Goa hotel property erstwhile owned by Blue Coast Hotels Ltd. The said balance auction proceeds are currently retained by IFCI Limited. Vide its order dated December 12, 2024, the Hon'ble Supreme Court, was pleased to *inter-alia*, disposed off the said interim application as withdrawn by the applicant.
